



### **04. Instructions and Training**

## Drafted syllabus of Intellectual Property Rights Law

### Objectives:

Intellectual Property Law has assumed a great importance in recent times as a result of the recognition that "knowledge is property". The creations of the human brain recognized as Intellectual Property are required to be understood and protected for creative work is useful to society. With this background the course aims to provide the following:

1. basic knowledge on the various branches of Intellectual Property Law.
2. holistic understanding of the legal regime governing Intellectual Property Rights.
3. disseminate information on national and international IPR issues.

### Course contents:

#### UNIT I

**Introductory Aspects:** Evolution of IP Rights, Different forms of IP and its conceptual analysis. International Convention and Treaties such as Paris Convention, Patent Cooperation Treaty, Madrid Convention, Berne Convention, TRIPS, World Intellectual Property Organization.

#### UNIT II

**Patents:** History of Patent protections; definition of patent; Object and salient features of patent; How to obtain patent; non-patentable inventions; Procedure for patent applications; Rights and obligations of patentee; Transfer of Patent Rights; Infringement of Patents; defences, Offences and Penalties and remedies; Patent Agents; Protection of Plant Varieties and Farmers' Rights.

--06 hrs.

#### UNIT III

**Trade Marks:** Evolution of trade mark law; Object of trade mark; Features of good trade mark; Different forms of trade mark; concepts of trademark; Registrable and non-registrable marks; procedure; term of protection; Assignment and transmission; Infringement of trade mark and defences; Passing off; Offences penalties and remedies; overview of domain names and their protection; protection of trade secrets.

--06 hrs.

#### UNIT-IV

**Indian Copyright Law:** History of copyright and related rights; Nature and salient features of Copyright Act; Subject matter of copyright; Term of copyright; Author and ownership of copyright; Rights conferred by copyright; Assignment, transmission and relinquishment of copyright; Infringement of copyright; Remedies; Computer software and copyright protection; Overview of copyright protection on internet.




