The College is directed to fulfill the conditions laid down by the Local Inquiry Committee and submit the compliance report.

Permanent Affiliation should be renewed once in Five (05) years (**2022-23 to 2026-27**). Subject to verification was done by the LIC Committee as per the provisions under Section 62(3) of the Karnataka State Universities Act 2000.

CONDITIONS:

1. As per the Karnataka State University Act-2000, U/S 61. No Further Admission shall be made beyond the intake limit set in column -3 mentioned above.
2. In Order to grant Permanent Affiliation of the College, the minimum Affiliation Score required as per the ONLINE AFFILIATION guidelines/criteria should be >65%. However, in the Academic year 2022-23 the Online Affiliation Score have come to **51.51%** (<65%).
3. As per Government Order, Renewal of Permanent Affiliation has been allowed with 5% discount in Affiliation Score for the current Academic year respectively.Hence, Permanent

Affiliation granted to the College from 2022-23 to 2026-27 Academic year will be canceled if the candidate does not Score >65% marks in the next TWO Academic years and does not complete 08 points of the prescribed criteria for Online Affiliation including land.

4. The condition imposed by the Local Inquiry Committee shall be strictly adhered to. And as per the stipulated ONLINE AFFILIATION Guidelines (Defined Parameters) the College shall be strictly followed.
5. The College shall follow the Rules and Regulations of the Government applicable from time to time without fail.
6. To renew the Academic composition of the College for the academic year 2027-28 and to subject the College to Physical inspection by the Local Inspection Committee under Karnataka State University Act-2000, Section 62(3), 2000.
7. The University Statutes, Regulations and Ordinances shall be strictly followed.
