
Proceedings of the meeting of Students Grievance Committee for the 2018-19 held on 2nd July t 2018 at 1.30 Pm at the Principal Chamber.



 - b. At least two members including chairperson of the grievance committee shall be present in a meeting.
 - c. SGRC shall follow the principals of natural justice while considering grievances of the students.
- 3. Procedure of submitting grievances:** Following are the highlights of the discussion.
 - a. The aggrieved student shall submit to the chairman in written or drop in the complaint box of her grievance/suggestion for improving academic and administration environment of the college.
 - b. Create awareness among the students about the grievance redressal mechanism.The meeting concluded with vote of thanks.
